PROSPECTUS

ELIGIBILITY

All active members of Seattle Co-Arts in good standing who have attended at least three meetings during the past 12 months as of and including January 2009 General Meeting are eligible to enter the 2009 Annual Juried Art Show. The Show Chair is ineligible to receive awards. Any painting accepted and shown in a previous Seattle Co-Arts Annual Show is ineligible for entry into the 2009 Annual Show.

SPECIFICATIONS

All entries must be the work of the entering artist, executed without the supervision of an instructor and not based on any copyrighted material. All mediums are acceptable. All art must have been created within the last two years. No paintings of nudes, please.

Paintings should be framed sturdily and ready to hang with an adequate hanging wire.

The total outside frame dimension may not exceed 130 inches.

All digital images will be kept on file with the show committee until paintings are delivered to the venue. All paintings must be exactly as they appear on the slides or digital images. Unless specifically informed in writing by the artist, Seattle Co-Arts reserves the right to photograph the paintings in this show for Co-Arts publicity, both in printed medium and on the Seattle Co-Arts website, www.seattlecoarts.com.

SALES

All sales will be handled by Community Center Mercer View Gallery. Mercer View Gallery will receive a 25% commission. A check for total sales during the run of this show will be given to Seattle Co-Arts within 10 days after the close of the show. Seattle Co-Arts will then pay the individual artists for their paintings.

DIGITAL ENTRIES

Seattle Co-Arts will accept ONLY DIGITAL SUBMISSIONS. There will be members available to help in photographing artwork for submission.

INSTRUCTIONS AND ENTRY INFORMATION

ENTRY FEE

The entry fee is \$15. Two digital images will be accepted with this \$15 fee, payable to Seattle Co-Arts.

SUBMISSION OF DIGITAL IMAGE

Digital images will be accepted on disk or via email, Kay@LookingGlassCottage.com. All disks must be labeled with the artist's name, title of painting, medium and framed size. All digital entries should be at least 1.5 megabytes and jpeg file format. Please include name, title of painting, medium, price, image size and framed size in the email or with the disk.

SUBMISSION OF ENTRY FORM AND FEE
